As you prepare for the convention, please keep these details in mind:

- Orientation for all delegates will be virtual and held on Tuesday, October 8
 at 6 p.m. We will provide an overview of the RA as well as share important
 updates and answer your questions. Look for a link to the virtual event in your
 email; we plan to conduct this orientation over Zoom.
- Hearings on RA business will be held on Wednesday, October 9 at 6 p.m.
 During the hearings, delegates will be able to ask questions about proposed
 rules of order, nominations and elections guidelines, resolutions, and bylaw
 amendments. A link to the virtual hearings will be emailed to delegates in
 advance of the hearings to be held on Zoom.
- Please plan to attend both the orientation and the hearings. These will be important opportunities to get up to speed on what we'll cover during the RA and ask questions.
- The deadline to submit amendments to resolutions, the rules of order, or the nominations and elections guidelines, and to submit new resolutions or new business items, is Friday, October 11 at 12 noon. More information can be found at marylandeducators.org/convention.
- You may also receive, or have already received, an email from the Cvent system noting your registration has been completed. If you need to modify or cancel your registration, you can do so upon receiving that email, and can also update the pronouns that may be displayed on your name badge. This will be an interactive session that is all about building our power and raising our voices.
